

COIN PERFORMANCE CONTEST RULES

COIN promotes musical quality in the fields of performative research, teaching, composition and musicology. In record time and in the short term, this music performance competition is convened in the fields of chamber music and choral music.

The reasons for the time and record deadline of the call respond to the nature of the moment, on the one hand, the harassment of the global pandemic and on the other hand the imminent official communication by the funding entity (Excmo. Ayuntamiento de Oviedo) to the organizing entity (SOCA-ISLIM Foundation) of the funds available for its organization.

Within 20 days the best cameristic and choral musical performances will be selected, following objective criteria set out in the heading announced in the call for papers under the name SEPA-M18 prepared by the educational evaluation service of the Principality of Asturias, available in the <https://tinyurl.com/y5kdgpfq> link, of recognized effectiveness in evaluation processes in competitive fields and by magazines such as the International Journal of Music Education of the International Society for Music Education under the title "On the design and validation of a rubric for the evaluation of performance in a musical contest" available on <https://tinyurl.com/yy2k7tp4>.

Based on the following regulatory rules:

1. Spanish is established as a language of communication (proposals in English, French or Italian will be accepted). All persons, natural and or legal, must be accredited with a copy of the corresponding document (passport, ID, ...).
2. Performers of any age (through legal representative minors) and any instrumental and vocal specialties may participate.

3. The following categories are established:

Camera Music Category:

1st Prize "Alicia de Larrocha", best performance, endowed with 8,000 euros

2nd Prize "Badura Skoda", endowed with 4,000 euros

3rd Prize "ISLIM", endowed with 2,000 euros

Choral music category:

1st Prize "Voices of Gold", best performance, endowed with 8,000 euros

2nd "Coral Quality" Award, endowed with 4,000 euros

3rd Prize "ISLIM", endowed with 2,000 euros

4. Participation Rules. Valid for both categories. Sending videos, affidavit and proof of payment of right of participation.

4.1 Applicants must send 3 videos recorded with performances in three different styles of free choice, each with a duration between a minimum of 3 minutes and a maximum of 9, via *wetransfer*, to cihm@islim.eu mail, before 20 December 2020

4.2. It is essential to register the COIN in <https://websoca.com/coin>, with the corresponding acceptance of the transfer of image rights and the payment of the fees indicated in any of the categories: "50€ (CONca Música de Cámara CONCURSO)" and /or "80€ (CONco Música Coral CONCURSO)". Admission must be made to the SOCA Foundation account with IBAN ES52 3190 0090 7440 7395 0125 and BIC BCOEESMM190 or through PayPal to the donate@islim.eu. To formalize participation in the contest you must send proof of payment next to the videos.

4.3. The decision on the award or not of the prizes corresponds to the committee of the congress chaired by the management of the congress. The organization reserves the right to declare desert any prize as well as to share or modify its amount and to incorporate prizes or recognitions based on the quality evaluated, as well as facilitating the entry at the semifinal level to the face-to-face contest. Participation in the competition implies acceptance of the bases and the jury's decision will be officially communicated before the end of 2020 by the corresponding certificate with digital signature of the FNMT.

4.4. The prizes will be effective in the two performances that the winners will perform in two events organized by the SOCA Foundation, both in the next edition of the COIN and / or International Chamber Music Festival, or event that determines the organization, at the percentage 50+50.
